Schools Limited Manufacture Licence

What Does it cover?

- > The **Schools Limited Manufacture Licence** is a joint licence from music rights organisations MCPS and PPL.
- ➤ The licence can be obtained via the <u>Centre for Education & Finance Management (CEFM)</u>.
- ➤ This is a specially designed licence which grants schools permission to legally use music within productions recorded or copied onto CDs, DVDs, USB and other devices.
- > The licence enables your school to produce content containing up to 120 minutes of music per copy. This allows the inclusion of music in content such as:
 - The recording of student performances
 - Student films containing music
 - Audio visual content for assemblies and presentations
 - Supporting materials for classroom learning
 - Recordings for curriculum requirements
- ➤ These items can be given away for free or sold by the school to parents as part of fundraising initiatives.



Schools Limited Manufacture Licence

Are there any restrictions?

> Recording television programmes

Requires a licence from the Educational Recording Agency (www.era.org.uk).

Promotional/training materials

Products that could be deemed promotional (i.e. school prospectus, materials for teacher training) would require prior approval from the rights holders.

> Grand Rights

Productions such as musical theatre plays, ballet or opera where characters and storylines are depicted will require a 'Grand Rights' licence to be obtained directly from the rights holders.

> Online

School websites or intranet for example will require a Limited Online Music Licence (LOML) through PRS for Music

> Public Performance

The showing or playing of a recorded product in public requires a Public Performance licence from PRS for Music and PPL which can also be obtained via CEFM cefm.co.uk/licensing

> England

The Department for Education (DfE) centrally pays for all schools and academies in England.

> Northern Ireland

The Educational Authority Northern Ireland (EANI) centrally pays for all maintained schools in Northern Ireland.

Scotland

Licensing is currently on a school by school or Local Authority basis

> Wales

Licensing is currently on a school by school or Local Authority basis

> Independent Schools

Licensing is currently on a school by school or Local Authority basis



What does it cover?

- ➤ A PRS for Music public performance licence grants permission to primary & secondary schools to play or perform music during non-curricular activities. This includes live recitals and the use of background music devices such as radios, TVs, CDs etc.
- ➤ We have a bespoke tariff for schools (Tariff EE); The annual licence fee is based on the no of pupils on the school roll at the start of the academic year. Annual fees start from £98.
- Activities covered by Tariff EE include:
 - All background music including staff rooms
 - School discos and dances
 - School sports events
 - Extra-curricular clubs and classes
 - PTA events
 - Music on hold on school telephone systems.
 - Dance/Aerobics classes, for students and staff of the school only



What does PRS not license?

- > Music played or performed as part of the curriculum
- > Use of the school as a rehearsal space
- > Use of the school for a family event



Are there any restrictions?

Grand Rights

Productions such as musical theatre plays, ballet or opera where characters and storylines are depicted will require a 'Grand Rights' licence to be obtained directly from the rights holders (often a music publisher). It is essential that you obtain such permission before beginning rehearsals, especially in the case of musicals.

Commercial uses

- Onsite gyms open to individuals not associated with the school and/or operated commercially.
- Featured music at events, run by a party other than the school or where any profit or benefit does not go entirely to the school. This includes concerts, theatrical performances, dance and aerobic classes.
- Performances at any other premises.



Is my school covered?

> England

The Department for Education (DfE) centrally pays for all state funded schools and academies in England.

> Scotland, Wales and Northern Ireland

Licences are issued by CEFM, who act as our licensing agent to collect royalties directly from the school or local authority.

> Independent schools

As above. CEFM act on our behalf to collect licence fees.



Limited Online Music Licence (LOML)

What does it cover?

- ➤ Limited Online Music Licence (LOML) is an annual blanket licence for digital services in the UK that offer musical content online to a UK audience.
- ➤ It is a joint PRS & MCPS Licence, covering the communication to the public (PRS) and associated mechanical rights (MCPS) of our member's repertoire when music is used within the following services:
 - Digital Downloads
 - Music On Demand
 - Interactive Webcast
 - Webcast
 - General Entertainment
 - Podcasts
 - Clips



Limited Online Music Licence (LOML)

Examples of Online Music Usage in Schools

Digital Downloads

 Offering copies of school performances and/or music content for students to download

Music On Demand

 Backing track of music on school website for pupils in a music class to play along at home

Webcast / Interactive Webcast

 Use of conferencing or education platforms (e.g., Zoom, Microsoft Teams, Google Classroom) for online teaching

General Entertainment

- Video playlist created by school showing highlights of recent school trip
- Use of school prospectus video on school website

Podcasts

- Creation of a podcast style show by students
